The Rich Township Board met at the Township Hall. The meeting was called to order by Supervisor Scheuer at 7:13 pm. We recited the Pledge of Allegiance.

Motion by Curell, supported by Harvey to approve the agenda. MOTION CARRIED.

Motion by Harvey, supported by Curell to accept into record the minutes of the March meeting as drafted. MOTION CARRIED.

Motion by Harvey, supported by Curell to accept into record the minutes of the March 30, 2020 Budget Public Hearing meeting. MOTION CARRIED.

Motion by Harvey, supported by Mohr to accept into record the Treasurers' Report as presented. MOTION CARRIED.

Motion by Curell, supported by Mohr to pay the monthly bills as follows: from the General Fund, \$11,200.32 with checks numbered 13250 through 13261, from the Cemetery Fund, \$615.00 with check number 1128, and from the Mosquito Fund, \$15,500.00 with check number 1071. MOTION CARRIED.

Brief discussion took place about the pavilion at the township hall, it was approved previously, we are still planning on going forward with the project.

Treasurer Curell let us know that the Choice account used for mosquito funds at Lakestone Bank will not be available for a time after the Bank changes to Choice One Bank.

Resolution by Curell, supported by Harvey to place a millage renewal for mosquito control on the ballot for the August 4, 2020 election. Upon roll call vote, the following voted "yes": Curell, Harvey, Mohr, Running, Scheuer. None voted "no". Resolution adopted.

Resolution by Curell, supported by Scheuer to place a millage renewal for roads on the ballot for the August 4, 2020 election. Upon roll call vote, the following voted "yes": Curell, Harvey, Mohr, Running, Scheuer. None voted "no". Resolution adopted.

Resolution by Curell, supported by Scheuer to approve a request by Mark Smith for a partial termination of a Farmland Development Rights Agreement (PA 116). Upon roll call vote, all members voted 'yes'. None voted 'no'. Resolution adopted.

Motion by Scheuer, supported by Curell to adopt the Solar Energy Amendment to our Zoning Ordinance. MOTION CARRIED.

There were 2 zoning permits issued since the last meeting: A. Stone, Jonathan 7168 Rich Rd Single Family dwelling 1240 sq ft; B. Romita, Carlo Property ID #'s 018-022-002-02 and 018-022-002-10 Pole Barn 175 x 40 (7000 sq ft).
