The Rich Township Board met at the Township Hall. The meeting was called to order at 6 pm. We recited the Pledge of Allegiance.

Members Present: Chittick-Harvey, Curell, Mohr, Running. Members Absent: Scheuer. Visitors: Jack & Joan Knowlton, Ron Gromak.

Due to the absence of Scheuer, motion by Running, supported by Chittick-Harvey to appoint Curell to chair the meeting. MOTION CARRIED.

Motion by Chittick-Harvey, supported by Running to approve the agenda. MOTION CARRIED.

Motion by Chittick-Harvey, supported by Curell to accept into record the minutes of the July meeting as drafted. MOTION CARRIED.

Motion by Chittick-Harvey, supported by Running to accept into record the Treasurers' Report as presented. MOTION CARRIED.

Motion by Mohr, supported by Running, to pay monthly bills from the General Fund, \$6894.52 with checks numbered13785 through 13800; from the Cemetery Fund, \$1851.92 with checks numbered 1184 & 1185, and from the Mosquito Account \$15,500.00 with check number 1088. MOTION CARRIED.

We discussed the situation with our former ordinance officer and getting possession of the files that he has. He was expected to be at the meeting tonight to turn them over but was ill and did not attend the meeting. We will wait a few more days and make efforts to contact him. Motion by Running, supported by Chittick-Harvey to approve 3 PA 116 applications from Paramount Enterprises, Brent Robinson, numbered 01-2022, 02-2022, and 03-2022 for parcel ID #'s 018-006-001-03, 018-006-006-02, 018-004-001-60, 018-004-001-40, 018-003-020-00, and 018-003-019-02. MOTION CARRIED.

There was brief discussion about election results.

There were 2 zoning permits issued since the last meeting: 1. Bryan Silvernail 678 Brown Road for a Solar Panel Array 2. Levi Ernst 227 Millington Road for a 30 x 50 pole barn.

Clerk has received 2 items of correspondence – Lapeer County EMS report and a letter regarding a county wide household hazardous waste collection scheduled for September 21 to take place in Imlay City. All agreed that our residents would likely not travel that far to participate, we may take part in a collection scheduled for next spring at a closer location.

During public comment time, questions were asked about when the Binden Road bridge will be done and if anyone knows about Lapeer Schools opening the Lapeer West building back up for students.
