The Rich Township Board met at the Township Hall. The meeting was called to order at 6 pm. We recited the Pledge of Allegiance.

Motion by Curell, supported by Chittick-Harvey to approve the agenda with the correction of the date to December 12, and, at the request of Curell, with the addition of 2 items, #13 - Marijuana, and #14 - Storage Containers. MOTION CARRIED.

Motion by Curell, supported by Chittick-Harvey to accept into record the minutes of the November meeting as drafted. MOTION CARRIED.

Motion by Scheuer, supported by Mohr to accept into record the Treasurers' Report as presented. MOTION CARRIED.

Motion by Scheuer, supported by Curell to pay monthly bills from the General Fund, \$17,113.39 with checks numbered 13860 through 13884. MOTION CARRIED.

Motion by Scheuer, supported by Curell to pay monthly bills from the Cemetery Fund, \$16.47 with check number 1194. MOTION CARRIED.

The Rich Township December Board of Review will meet on December 13, 2022 at 4 pm at the township hall.

Motion by Curell, supported by Scheuer to set township board meeting dates for calendar year 2023 to be the 2<sup>nd</sup> Monday of each month at 6 pm. MOTION CARRIED.

Motion by Scheuer, supported by Chittick-Harvey to reappoint Gary Curell, Gary Harvey, Krystal LaBair, and Darlene Lott to serve on the Planning Commission for the calendar years 2023 and 2024. MOTION CARRIED.

There were 3 zoning permits issued since the last meeting: A. Gallagher, Shawn & Ashley, 2475 Barnes Rd, 018-023-013-10, for a 48 x 30 Pole Barn B. Oliver, Hunter, Nelson Lane, 018-032-011-08, for a 56 x 30 Pole Barn C. Henne, Connie, 1933 Dwyer, 018-027-008-00, for a Remodel, (Porch).

Clerk reported 2 items of correspondence, a letter from Jim Welke of Mayville Area Ambulance Service asking for volunteers, and a letter from DTE about tree trimming in the area of the township hall.

There was discussion about ordinance enforcement. Curell suggested paying Scheuer and Gromak for the time they have spent on such. Motion by Chittick-Harvey, supported by Mohr to pay Scheuer and Gromak \$17 per hour for their time to investigate violations and enforce our township ordinances, and to pay them mileage.
