

January 11, 2021

The Rich Township Board met at the Township Hall. The meeting was called to order by Supervisor Scheuer at 7 pm. We recited the Pledge of Allegiance.

Members Present: Curell, Harvey, Mohr, Running, Scheuer. Members Absent: None.

Visitors: Jack & Joan Knowlton, Mark Jaruzel, Ron Randall, Lee & Sue Myers, Brendan Miller.

Motion by Curell, supported by Scheuer to approve the agenda. MOTION CARRIED.

Motion by Harvey, supported by Curell to accept into record the minutes of the December meeting as drafted. MOTION CARRIED.

Motion by Mohr, supported by Scheuer to accept into record the Treasurers' Report as presented. MOTION CARRIED.

Motion by Harvey, supported by Curell to pay the monthly bills as follows: from the General Fund, \$6020.29 with checks numbered 13430 through 13441, and from the Cemetery Fund, \$605.00 with check number 1146. MOTION CARRIED.

Brenden Miller gave an update on the business of the county. Items included a new county administrator, Miller being named personnel chair, and the organization of a 1st District Advisory Committee. He asked for a volunteer from our Board to serve on the committee, Harvey agreed to do this.

Unfinished Business:

Ceiling in ladies rest room still needs to be fixed. Scheuer volunteered to take care of it.

We had discussion about the hall rental fee. Motion by Harvey, supported by Curell to raise the rental fee for the township hall, effective immediately, to \$150 for residents of the township and \$200 for non-residents, with an additional \$50 deposit required for both residents and non-residents. Rentals that are on the calendar for this year already will pay the previous applicable fee. MOTION CARRIED.

Motion by Curell, supported by Harvey to charge \$50 to rent the pavilion, with an additional \$50 deposit. MOTION CARRIED.

Motion by Curell, supported by Running to approve the proposed contract with Wilkinson Solutions for two (2) applications of seasonal dust control at a total cost of \$18,200 if prepaid by February 28, 2021. MOTION CARRIED.

Scheuer nominated Gary Harvey for alternate on the Board of Review. Motion by Curell, supported by Harvey to reappoint Jerry Strich, Garry Running, and Leroy Myers to serve on the Rich Township Board of Review for a term of 2 years (2021 & 2022), and for Gary Harvey to serve as alternate for the same term. MOTION CARRIED.

There were 2 zoning permits issued since the last meeting: 1. Randy Nord, Solar Panel Array, 7838 N Lapeer Rd, 018-028-003-10. 2. David Gibson, 9350 N Lapeer Rd (Golf Course), 20'x16' addition, 018-009-008-00.

Public comments/questions were received about the Binden Road bridge, and the culvert near 1885 Millington Rd where the gravel is washed out at the edge of the road. Scheuer will contact road commission to have them put a marker at the location.

Motion by Curell, supported by Harvey to adjourn. Meeting adjourned at 8:05 pm.
