June 11, 2018

The Rich Township Board met at the Township Hall. The meeting was called to order by Supervisor Scheuer at 7:00 pm. We recited the Pledge of Allegiance.

Members Present: Curell, Harvey, Mohr, Running, Scheuer. Members Absent: None.

Visitors: Dustin Drabek, Keith & Mariann Fleckenstein, Jack Knowlton, Shari Emerick, Arlene Sullivan, Dennis Barefoot, Cheryl Clark.

Motion by Curell, supported by Harvey to approve the agenda. MOTION CARRIED.

Motion by Curell, supported by Harvey to accept into record the minutes of the May meeting as drafted. MOTION CARRIED.

Motion by Running, supported by Scheuer to accept into record the Treasurers Report as presented and to pay the monthly bills: from the General Fund, \$20,497.64 with checks numbered 12824 through 12852, from the Cemetery Fund, \$877.25, with checks numbered 1093 and 1094, and from the Mosquito Fund, \$15,500 with check number 1061. MOTION CARRIED.

Motion by Scheuer, supported by Running to have Scheuer and/or Running check out other propane prices before we enter into a contract for propane for next year. MOTION CARRIED.

County Commissioner Cheryl Clark gave a report on various meetings and programs.

Scheuer received a verbal estimate of \$6000-\$6500 including concrete. Cheryl Clark stated she could help find a grant.

Scheuer has received an offer from a local businessman for providing us with a new flagpole and is looking into it.

There was discussion about internet at the hall and the telephone. Motion by Curell, supported by Harvey to have the phone at the township hall disconnected. MOTION CARRIED.

Motion by Scheuer, supported by Harvey to allow Planning Commission members who wish to go to the MTA Planning & Zoning workshop in Frankenmuth on July 19 to do so at the expense of the township. MOTION CARRIED.

Motion by Harvey, supported by Scheuer to allow Clerk to attend the 2018 Michigan Association of Municipal Cemeteries Conference in Frankenmuth August 15-17. MOTION CARRIED.

Motion by Curell, supported by Scheuer to establish a \$50 Administration & Recording Fee for cremation burials that go into a special headstone. MOTION CARRIED.
