

March 16, 2020

The Rich Township Board met at the Township Hall. The meeting was called to order by Clerk Running at 5 pm. We recited the Pledge of Allegiance.

Members Present: Curell, Harvey, Mohr, Running. Members Absent: Scheuer.

Visitors: Steve Nihranz, Mike Papiez, Mike Creason, Dennis Barefoot, Ron Gromak.

Motion by Running, supported by Harvey to appoint Curell to chair the meeting in the absence of the supervisor. MOTION CARRIED.

Motion by Curell, supported by Harvey to approve the agenda with the addition of Steve Nihranz of Right Touch Landscaping. MOTION CARRIED.

Steve informed us there will be no increase in contract amounts and asked us to approve spraying for dandelions at the cemetery this year. We do not have the spraying done every year.

Motion by Harvey, supported by Mohr to have Steve make arrangements for spraying dandelions at the cemetery, contacting the clerk for approval if there is a large increase in the cost. MOTION CARRIED.

Motion by Harvey, supported by Mohr to accept into record the minutes of the February meeting as drafted. MOTION CARRIED.

Motion by Harvey, supported by Running to accept into record the Treasurers' Report as presented. MOTION CARRIED.

Motion by Mohr, supported by Harvey to pay the monthly bills as follows: from the General Fund, \$26,621.52 with checks numbered 13210 through 13248, and from the Cemetery Fund, \$653.92 with checks numbered 1126 & 1127. MOTION CARRIED.

Motion by Running, supported by Mohr to amend the 2019 Budget in the following amounts: Board of Review, \$900; Drains, \$5000; Payroll Expenses, \$40; Ambulance \$1550; Street Lights, \$200. MOTION CARRIED.

Discussion was had on the process of approving the solar ordinance, it was decided to postpone this action until April as the minutes of the Planning Commission need to be corrected.

Motion by Harvey, supported by Running to hold our Budget Public Hearing on March 30 at 5 pm for the fiscal year 2020-2021 Budget. MOTION CARRIED.

Motion by Harvey, supported by Mohr to move interest that has accrued on a Cemetery Fund CD at Mayville State Bank, to a Cemetery Fund Savings account at Lakestone Bank. MOTION CARRIED.

There was 1 zoning permit issued since the last meeting, to Jonathan Stone 7168 Rich Road for a 40 x 30 house.

There were 2 items of correspondence. One was a notice about a property, 1650 Swaffer Road, that will be auctioned. This notice was found on the door when we arrived for the meeting. The other item was an operational report from the Mayville Area Ambulance Service.

Public comment was received about the condition of the roads, and a question was asked about when the aerial larviciding for mosquito control will be done.

Motion by Running, supported by Harvey to adjourn. Meeting adjourned at 5:31 pm.
