The Rich Township Board met at the Township Hall. The meeting was called to order by Supervisor Scheuer at 7:00 pm. We recited the Pledge of Allegiance.

Members Present: Harvey, Mohr, Running, Scheuer. Members Absent: Curell.

Visitors: Jack & Joan Knowlton, Ron Randall, Arlene Sullivan, Shari Emerick, Dennis Barefoot, Brendan Miller, Mark Jaruzel.

Motion by Harvey, supported by Running to approve the agenda. MOTION CARRIED.

County Commissioner Brendan Miller gave a report on various business of the county including a letter of intent for County Mental Health to become an authority, a Citizens Probation Council meeting, another employee to be added to Animal Control, and the Sheriffs' Department employee assistance program.

Motion by Harvey, supported by Scheuer to accept into record the minutes of the April meeting as drafted. MOTION CARRIED.

Motion by Mohr supported by Scheuer to accept into record the Treasurers Report as presented. MOTION CARRIED.

Motion by Harvey supported by Scheuer to pay the monthly bills as follows: from the General Fund, \$4124.52 with checks numbered 13036 through 13045, from the Cemetery Fund, \$492.10, with checks numbered 1111 & 1112, and from the Mosquito Fund \$15,500.00 with check number 1066. MOTION CARRIED.

Scheuer has been in contact with property owners of 712 Barnes Road about tires on the property, he will turn over to Construction Code.

Scheuer will purchase special paint for the propane tank at the hall and apply.

Scheuer investigated propane prices with several different companies. Motion by Harvey, supported by Mohr to obtain propane from Hamilton this year. MOTION CARRIED.

Motion by Scheuer, supported by Harvey to purchase a flagpole and have it installed. MOTION CARRIED.

Motion by Running, supported by Scheuer to approve PA 116 applications from Mitchell & Krystal LaBair for Parcel # 018-007-005-01, and from Karen Curell for Parcel # 018-008-011-01. MOTION CARRIED.

There were 2 zoning permits issued since the last meeting:

A. Traubenkraut 2025 Murphy Lake Road for a Solar Array (ground)

B. Christopher Coutts 2629 Castle Road 30x40 Garage (attached)

Motion by Harvey, supported by Scheuer that the township will pay for board members who wish to attend the MTA Training class on assessing in Frankenmuth on June 25, 2019. MOTION CARRIED. Members to let the clerk know before May 28 if they wish to attend.

Public comments were received that the board is doing a great job, the County cut down the tree that was leaning over Barnes Road east of M-24, the replacement of the bridge on Barnes Road was discussed, and it looks like the township will be paid by the insurance company for the fire department response to a 1 vehicle accident that happened back in January on Barnes Road.

Motion by Mohr, supported by Running to adjourn. Meeting adjourned at 7:52 pm.
