## November 12, 2018

The Rich Township Board met at the Township Hall. The meeting was called to order by Supervisor Scheuer at 7:00 pm. We recited the Pledge of Allegiance.

Motion by Curell supported by Harvey to approve the agenda. MOTION CARRIED.

Motion by Curell, supported by Scheuer to accept into record the minutes of the October meeting as drafted. MOTION CARRIED.

Motion by Harvey, supported by Running to accept into record the Treasurers Report as presented. MOTION CARRIED.

Motion by Scheuer, supported by Mohr to pay the monthly bills: from the General Fund, \$4,684.59 with checks numbered 12934 through 12948, and from the Cemetery Fund, \$760.00, with check number 1103. MOTION CARRIED.

## UNFINISHED BUSINESS:

Motion by Scheuer, supported by Harvey to remove a fire run at 1800 Murphy Lake Road from the tax roll as it has been paid. MOTION CARRIED.

Motion by Scheuer, supported by Harvey to have Curell pursue a 4G contract with Verizon for internet service at the hall. MOTION CARRIED.

We received an update from Curell about the Tax Tribunal case for the golf course. The assessor and attorney Hallahan felt it would be best to settle and lower their values since it seemed that they were valued too high and this would avoid more in attorney fees than what would be gained in taxes. It was noted that they were asking for the value to be lowered below what farm land values are in the township.

## **NEW BUSINESS:**

Resolution by Curell, supported by Scheuer to adopt the proposed wind energy ordinance as recommended by the Planning Commission. Upon roll call vote, all members voted yes. The resolution was declared adopted. Resolution attached.

Clerk gave a report on unofficial election results and turnout. There were a total of 643 voters, including 95 absentees.

Joe Zanetti from APM gave some figures about mosquito control for the 2018 season. APM has presented a proposed contract.

There were 3 zoning permits issued since the last meeting, to Brian Brandt 2323 Dodds for a pavillion-open shed; to Shelley and Antonio Carrillo 240 Millington for a shed; and to Shelley and Antonio Carrillo 240 Millington for a porch awning.
