The Rich Township Board met at the Township Hall. The meeting was called to order by Supervisor Scheuer at 7 pm. We recited the Pledge of Allegiance.

Members Present: Curell, Mohr, Running, Scheuer. Members Absent: Harvey Visitors: Mark Jaruzel, Ron Gromak, Ron Randall, Dennis Barefoot.

Motion by Curell, supported by Running to approve the agenda. MOTION CARRIED. Motion by Scheuer, supported by Curell to accept into record the minutes of the August meeting as drafted. MOTION CARRIED.

Motion by Scheuer, supported by Mohr to accept into record the Treasurers' Report as presented. MOTION CARRIED.

Motion by Curell, supported by Scheuer to pay the monthly bills as follows: from the General Fund, \$24,312.94 with checks numbered 13327 through 13359, from the Cemetery Fund, \$1201.62 with checks number 1137 & 1138, and from the Mosquito Fund, \$15,500.00 with check number 1075. MOTION CARRIED.

We reviewed 3 bids received by Scheuer for the construction of the pavilion in the yard at the township hall. Motion by Scheuer, supported by Curell to approve the lowest bid by Freeman Construction and have them get started. MOTION CARRIED.

Motion by Curell, supported by Scheuer to pay Freeman in steps as the work is finished. MOTION CARRIED.

Scheuer gave a report on bridge projects. There is a problem with a culvert on Millington Road that may affect the bridge on Binden. This situation is being evaluated by drain and road commissions, someone from road and/or drain commission will be at our October meeting to explain.
