The Rich Township Board met at the Township Hall. The meeting was called to order by Supervisor Scheuer at 7 pm. We recited the Pledge of Allegiance. Mark Jaruzel opened with prayer.

Motion by Curell, supported by Chittick-Harvey to approve the agenda. MOTION CARRIED.

Motion by Curell, supported by Chittick-Harvey to accept into record the minutes of the August meeting as drafted. MOTION CARRIED.

Motion by Mohr, supported by Chittick-Harvey to accept into record the Treasurers' Report as presented. MOTION CARRIED.

Motion by Scheuer, supported by Curell to pay monthly bills from the General Fund, \$19,528.49 with checks numbered 13558 through 13589. MOTION CARRIED.

Motion by Chittick-Harvey, supported by Mohr to pay monthly bills from the Cemetery Fund, \$1510.56 with checks numbered 1162 and 1163. MOTION CARRIED.

Motion by Scheuer, supported by Running to pay the monthly bill from the Mosquito Fund, \$15,500 with check number 1082. MOTION CARRIED.

Ron Gromak was asked to have the Planning Commission consider the pros and cons of allowing 2 homes on a property.

There was discussion about raising the fee for Zoning Permits. Further discussion of this topic is tabled until next month.

Motion by Scheuer, supported by Curell to allow the clerk to spend up to \$100 for refreshments for the Lapeer County Municipal Clerks' Association meeting to be held at Rich Township on Wednesday, September 15. MOTION CARRIED.

There were 2 zoning permits issued since the last meeting: to 1. Steve Mathews for a new home 70 x 26 at 2681 Turtle Lake Road 018-025-008-25; and 2. Thomas Grosskopf for a 64 x 40 pole barn at 1145 Millington Road 018-016-013-00.

The clerk presented 2 items of correspondence – a letter from DTE stating that they will be doing tree trimming in the area of the cemetery and a Notice of Approval received by email from the Michigan Dept of Treasury regarding our application for ARPA (American Rescue Plan Act) funds.

Public comments were received regarding the Binden Road bridge, the possibility of licensing home businesses for safety reasons, and some dead trees at the cemetery that need to be taken care of.
