## November 13, 2023

The Rich Township Board met at the Township Hall. The meeting was called to order at 6:01 pm. Members Present: Scheuer, Kester & Chittick-Harvey. Absent: Moore & Curell. We recited the Pledge of Allegiance.

Visitors: Dan Hurd, Ron Gromak, Gary Harvey, Rich Moore, Jack & Joan Knowlton, Pete Kirly, Mark Jaruzzel, Steve Nihranz, the APM Mosquito Team & Tom Sansote.

Motion by Kester, supported by Chittick-Harvey to approve the agenda. MOTION CARRIED. Motion by Scheuer, supported by Chittick-Harvey to accept into record the minutes of the October meeting as drafted. MOTION CARRIED.

Motion by Scheuer, supported by Chittick-Harvey to accept into record the Treasurers' Report as presented. MOTION CARRIED.

Motion by Kester, supported by Chittick-Harvey to pay monthly bills from the General Fund, \$50,854.45 with checks numbered 14058 through 14069. (None from the Mosquito Account.) MOTION CARRIED.

Motion by Kester, supported by Chittick-Harvey to pay monthly bills from the Cemetery Fund \$2,424.94 with checks numbered 1214 & 1215. MOTION CARRIED.

Scheuer informed the board of the County Commissioner's report & brought up the subject of purchasing a warning siren. The board decided to vote on the siren in December. Motion by Scheuer Supported by Kester. MOTION CARRIED.

Kester talked about some of the issues at the cemetery that were addressed by Steve since the last meeting. All future complaints about the cemetery landscaping/mowing will go to Scheuer. The Board of Review date will be announced later on for next month's meeting. APM gave their final Mosquito report of the 2023 season.
