The Rich Township Board met at the Township Hall. The meeting was called to order at 6:00 pm.

Members Present: Scheuer, Chittick-Harvey, Kester, Curell & Jaruzel. Absent: None. We recited the Pledge of Allegiance.

Visitors: Dan Hurd, Ron Gromak, Richard, Shawn, Gavin & Brad Mohr, Jack & Joan Knowlton, Mike Papiez, Dennis Barefoot, Aaron Kester, Steve Nihrantz & Tom Sansote.

Motion by Curell to approve the Agenda, supported by Kester. MOTION CARRIED.

Motion by Curell, supported by Chittick-Harvey to accept into record the minutes of the February meeting. MOTION CARRIED.

Motion by Scheuer, supported by Kester to accept into record the Treasurers' Report as presented for the General fund. MOTION CARRIED.

Motion by Scheuer, supported by Jaruzel to accept into record the Treasurers' Report as presented for the Cemetery fund. MOTION CARRIED.

Motion by Curell, supported by Scheuer to pay monthly bills from the General Fund, \$35,066.03 (with two corrected checks for Chittick-Harvey & Jaruzel) with checks numbered 14124 through 14155; none from the Mosquito Account; and a motion by Curell, supported by Chittick-Harvey to pay the monthly bills from the Cemetery Fund \$1,347.23 with checks numbered 1221 & 1222. MOTION CARRIED.

Motion by Curell, supported by Chittick-Harvey to put spend no more than \$2,100 to put limestone down in the parking lot. MOTION CARRIED.

Motion by Curell, supported by Kester to approve Scheuer's nomination of Aaron Kester & Mark Smith to the Planning Commission. MOTION CARRIED.

Motion by Scheuer, supported by Kester to adopt the amended Cemetery rules with the change of "The Rich Twp. Sexton shall do all lawn mowing." to "The Rich Twp. Sexton or Someone with approval by the Rich Twp. Board shall do all lawn mowing." MOTION CARRIED.

Motion by Chittick-Harvey, supported by Jaruzel, for Scheuer to divide the sections or negotiate the fire contract for the twp. with Mayville Fire Dept. MOTION CARRIED.

Kester reviewed the 2023-34 budget/suggested breaking down certain accounts further to add clarity. Motion was made by Curell, supported by Jaruzel to accept the 2024-25 proposed budget for the General & Cemetery funds. MOTION CARRIED.

Motion by Curell, supported by Kester to accept the proposed Mayville Ambulance contract for 4/1/2024-3/31/2025. MOTION CARRIED.

Public Comment: Joan Knowlton explained where the Hall planning was at and the progress they had made. They need more time to get the plans together. In regards to the cemetery, the Township will receive bids for mowing and wants an updated contract/bond/list of what will be done from Right Touch Landscaping.
